

## ONLINE GIVEAWAY TERMS & CONDITIONS

### **Giveaway Terms & Conditions:**

The following Terms and Conditions apply to the “Silky Spring Giveaway: Dining In Abundance Cash Vouchers worth RM750\*” (“Contest”) which is organised by the management of UOA Group [u1] (“Organiser”). Any person who participates in the Contest, whether directly or indirectly (“Participant”), shall be deemed to have read, understood and agreed to be bound by the Terms and Conditions herein contained.

#### **1. Adherence to Contest Terms and Conditions**

By participating in the Contest, the Participant will be deemed to have read, understood and agreed to be bound by the Terms and Conditions herein contained, and the decisions of the Organiser.

The Organiser reserves the right to vary or change the dates and duration period of the Contest at any time without prior notice.

The following persons (which shall be determined by the Organiser at its sole and absolute discretion) shall not be eligible to participate in the Contest: –

3.2 Any permanent and/or contract employees to the management of UOA Group, UOA’s subsidiaries and/or companies affiliated to UOA Group, and their immediate family members.

Winner(s) will be notified by Facebook Private Messenger or Instagram Direct Messenger to redeem his/her Prize (s) at Bangsar South upon receiving the complete personal details from the winner(s). The Organiser shall not be responsible in any manner whatsoever for the winner(s) not receiving the messages.

## **6. Rights of The Organiser**
